You should note that the cost of your Group Insurance may differ to the premium rates shown in the tables above as the rates that will apply to you may be affected by occupation and medical loadings applied by the Insurer. The premium rates shown include any applicable taxes.

You can contact Customer Services on **1800 892 353** to find out your occupational category and smoker status for your Death Only or Death & TPD cover. They can also assist you if you need to change these but this may affect the amount of insurance premium you pay for your cover.

There are five occupational categories:

- 1. Professional
- 2. White
- 3. Light Blue
- 4. Heavy Blue Skilled
- 5. Heavy Blue Unskilled.

Occupational loadings are the least (i.e., least cost) for occupational category 1 above and increase for each category up to 5.

## Formula to calculate your annual premium

The formula to calculate your annual premium for Death Only or Death & TPD cover using the premium rates in the table on the previous page is:

Annual premium = (premium rate x occupational loading) x Cover amount ÷ 1,000
