This Product Update is to be read in conjunction with the Mentor Portfolio Service (Service) Investor Directed Portfolio Service Guide (IDPS Guide) dated 1 July 2022 and any other disclosure documents issued by IOOF Investment Services Ltd (Operator) in connection with the Service.

### Ability to trade Australian listed securities across multiple exchanges

Effective immediately, we're introducing new functionality that allows the Authorised broker **to place trades for approved Australian listed securities across multiple exchanges**, including (but not limited to) the Australian Stock Exchange (ASX) and Cboe Australia (CBOE).

### Update to the IDPS Guide to accommodate multiple exchanges

***As a result of this change, the "Australian listed securities" section on page 6 of the IDPS Guide should be replaced with the below updated content:***

#### ***"Australian listed securities***

Access a selection of approved listed securities (including ordinary shares, property trusts, exchange traded products and listed investment companies) that can be traded on the Australian Securities Exchange (ASX) or such other exchanges as are approved from time to time."

***As a result of this change, the content under "AUTHORISED BROKER" in the information graphic on page 8 of the IDPS Guide should be replaced with the below updated content:***

- "Listed Securities – investments listed on the Australian Stock Exchange (ASX) or such other exchanges as are approved from time to time. Listed Securities may be referred to as shares."

***As a result of this change, the "Key information" content for "Australian listed securities" on page 10 of the IDPS Guide should be replaced with the below updated content:***

"A wide selection of eligible Australian listed securities that can be transacted on the relevant exchange."
