### Use this form to confirm your eligibility to make certain contributions to superannuation from age 67.

If you are age 67 to 74 (inclusive),<sup>1</sup> or turning 67 in the financial year stated in section 1 below and intend to continue making contributions once you reach age 67, you must meet the work test, or work test exemption, before we can accept certain superannuation contributions, including:

- non-mandated employer contributions eg salary sacrifice
- personal contributions
- spouse contributions (which can only be accepted until the member turns 75).

#### Important information

- This form is not required to be completed:
  - for us to accept mandated employer contributions, such as superannuation guarantee or contributions that satisfy an industrial award or agreement
  - if you are making a downsizer contribution. If you wish to make this type of contribution, please complete the relevant Australian Taxation Office form and provide it to us when or before the contribution is made.

- Before completing this form, we suggest that you confirm with your adviser whether you are eligible to contribute.

#### What it means to meet the work test

You have been gainfully employed<sup>2</sup> for at least 40 hours in a period of not more than 30 consecutive days during the financial year in which the contribution is made. The work test must be met before the contribution can be accepted by the fund.

#### What it means to satisfy the work test exemption

- You were gainfully employed<sup>2</sup> for at least 40 hours in a period of not more than 30 consecutive days in the previous financial year, AND
- Your total superannuation balance at the end of the previous financial year was less than \$300,000, AND
- You have not previously relied on this work test exemption to make contributions in any prior financial year.

**Note:** The Work Test Exemption can only be used to make contributions in the financial year you satisfy the exemption criteria.
